Goals of the Program

- To provide individuals with better information regarding Social Security and how they can be impacted by wages.
- Help individuals retain jobs for longer periods of time due to increased satisfaction with work through social security incentive programs.

If you are currently receiving SSI or SSDI benefits, you probably know the fear and uncertainty of trying to find employment and not knowing how that will affect your benefits...and your life. We can help.

What We Do
